WCWC Club History

WCWC was started in September 1996 by 2 gentlemen in the back room of the Duenke Cabinet Company in Manchester, MO. Meetings have been held regularly in various locations ranging from the Cabinet Company, the Ballwin City hall, Local Library and the current location at Salem in Ballwin. Over the years the club has had a presence in Ballwin Days, Manchester Homecoming, Open house at the Wild Canid Center, Faust Park, Midwest Artistry in Wood, as well as various shows in the St. Louis area. Our members have assisted various area charities through the sales of ornaments at the shows and appearances. Currently our club has a membership of around 35 men and women ranging in age from 10 to Retired.

Membership

The club membership is open to all 10 years or older from beginner to expert carver. The club membership is \$5.00 per year for associate member (under 18), \$10.00 per year for adults, \$20 maximum for family per year and \$3.00 for the WCWC patch. A \$1.00 donation is requested at each meeting a member attends and a \$2.00 fee for any Saturday carving. This money is to pay for use of the church fellowship hall rental.

Meeting

Two meetings each month are held at 14825 Manchester Rd. (*Salem in Ballwin United Methodist Church*) in Ballwin, Missouri. The meetings are on the first and third Monday of each month except holidays from 7PM to 9PM in the fellowship hall. Door opens between 6:00 and 6:30pm. The meetings start with a short business session followed by a discussion about carvings that members bring to the Show-an-Tell table. Monthly projects are available to any and all members for a nominal cost and the balance of the evening is allowed for carving of that or any other projects brought by the member. Questions are welcome and encouraged. Additional carving sessions are held in the fellowship hall the 2nd and 4th Thursday though-out the year from 9am to 12pm.

Carving

Informal and technical carving sessions are held at each of the club meetings. At the meeting the members work on the different projects such as carving in the round, caricatures, birds, animals, ornaments, wood burning, gourds etc. Help will be given to any club member at any time during the meeting, just ask. The WCWC encourages its members to participate in wood carving shows and schools. Members are also encouraged to learn to sharpen and maintain their own tools.

In exchange for participation in the crafting activities and services provided by West County Woodcarvers, (WCWC) including but not limited to painting, using tools, blades, open flames, nails, leather punches, or glue, woodworking, woodcarving and/or use of the property, facilities, and/or other products or services (the "Activities"), the individual named below (referred to as "I", "myself" or "me") agrees to the following terms and conditions set forth in this agreement (this "Agreement").

- 1. **Agree to Follow Directions:** I agree to observe and obey all posted rules and warnings, and further agree to follow any instructions or directions, whether written or oral, given by WCWC, its WCWC officers, directors, volunteers or agents.
- 2. **Assumption of Risk, Waiver, and Release**. I am aware and understand these activities involve an element of risk and danger of accidents and i knowingly assume those risks. In consideration for being permitted by WCWC to participate in the activities, i hereby waive, release, and discharge any and all claims, now known or hereinafter known in any jurisdiction, for damage for personal injury, death, emotional harm, property loss or damage or any pecuniary harm which i may have, or which may hereafter accrue to me, as a result of participation in said activities. This agreement is to be binding on my successors and assigns.
